

TERMS AND CONDITIONS OF PARTICIPATION

Only complete applications which are submitted within 30 (thirty) days from the date of purchase shall be accepted. After you send the online application, you can print the confirmation that your application has been received. 31 days after the registration, you can check the status at <https://warrantycheck.epson.eu>.
4. Epson standard producer warranty shall remain valid for all purchased products, irrespective of the above campaign. The respective conditions can differ depending on the country and product. This warranty is offered to you by the company of Epson group depending on which country you purchased Epson product in. You can find more information about the scope of warranty and its conditions for ActionPrinter at www.epson.eu/warranty.

5. These terms and conditions of participation shall not affect your legal claims under a guarantee.
6. This campaign shall only apply for the persons who are 18 or older and have their place of residence in one of the following countries where they purchased the selected printer: Germany, Austria, Switzerland, France, Italy, Spain, Portugal, the Netherlands, Belgium, Finland, Norway, Denmark, Sweden, the United Kingdom, Ireland, Hungary, Poland, Romania, Slovakia, Estonia, Lithuania, Latvia, Bulgaria, the Czech Republic, Macedonia, Croatia, Kosovo, Montenegro, Slovenia, Malta, Cyprus, Greece, Serbia, Albania, Bosnia and Herzegovina.
7. The persons who are directly involved in this campaign, shall be excluded from the participation. Specialist dealers and retailers are not permitted to participate in their own name.
8. If you return the Epson product (to a specialist dealer), you shall forfeit the right to the extended warranty. This condition shall not affect your legal claims under a guarantee.
9. Within the framework of this campaign, you can submit not more than one (1) application per product (unique serial number) during the campaign period.
10. The extended 3 year warranty cannot be granted, if:
 1. the printer cannot be identified as ActionPrinter or is not purchased within the offer period, and/or
 2. the application form for registration is not truly or fully completed, and/or
 3. the application form for registration is not sent to Epson within thirty (30) days from the date of purchase.
11. Epson shall not accept any liability for the loss or damage of any kind as regards technology, printer, software, server or website that prevents the participant from taking the offer.
12. Epson reserves the right to inspect all claims for their compliance with the terms and conditions of participation and demand additional information regarding the application form for registration and other documents.
